AGREEMENT made this Twenty Fifth day of November 1925, between A B SVENSK FILMINDUSTRI a stock company of the city of Stockholm, Sweden, Europe, hereinafter called the buyer and THE RUDOLPH WURLITZER COMPANY, an Ohio Corporation, with offices at 120 West 42nd Street, Borough of Manhattan, New York City, hereinafter called the seller, WITNESSETH:

(1) That the seller will build and instal for the buyer in the "SCANDIA" THEATER in accordance with the annexed specifications and design a WURLITZER HOPE JONES UNIT ORCHESTRA, Style "E", ready to be shipped from our factory at the end of January 1926, such time, however, not to be considered the essence of this contract.

(2) That the buyer will receive such Wurlitzer Hope Jones Unit Orchestra and pay the seller therefor the sum of \$13,750.00 less 10% or \$12,375.00 net, F.O.B. factory North Tonawanda, N.Y. plus export packing, freight and insurance, as follows: \$5,093.75 dollars in cash on the execution hereof, receipt whereof is hereby acknowledged, the balance to wit \$9,281.25 dollars against shipping documents in New York, N.Y.

(3) The buyer shall at his own expense, prepare and complete such necessary place, platform, pit and position as the seller shall require for the installation and location of said Wurlitzer Hope Jones Unit Orchestra, motor blower and attachments, furnish suitable foundation for same and bring the required current to the motor, and supply any necessary wind trunking, power, light and heat during installation and also for the operation of said instrument, and shall, during the final tuning and voicing of said instrument cause to prevail in said premises uninterrupted quietness.

(4) The seller shall have the right and privilege at any reasonable time to exhibit such Wurlitzer Hope Jones Unit Orchestra to perspective purchasers and other interested persons and upon the program and other advertising matter directly adjacent to the main program, the buyer will, where possible, print the words "MUSIC FURNISHED BY WURLITZER UNIT ORCHESTRA" and will not advertise or designate it otherwise or by any other description.

(5) The seller will furnish free of cost to the buyer F.O.B. North Tonawanda N.Y. any part of the said instrument that shall fail through inferior workmanship or material for a period of one year from date of installation and upon the failure of the seller to do so, the buyer may do so and charge the same to the account of the seller. The foregoing does not include, however, tuning, regulating or caring for motor or blower.

(6) Title to such instrument shall not vest in the buyer until payment in full therefor, has been made.
